Asked about calls for the state government to compensate residents affected by the pollution, he said: asked for compensation. In fact, some want the bauxite mining operations to continue.

The Penang Consumers' Association had urged the state government to compensate residents affected by the mining.

Bukit Goh Bauxite Coordinating Committee chairman Datuk Dr Abd Wahid Abd Manap said the government could send officials to carry out inspections and draft a standard operation procedure to be followed by all parties concerned.

He said the government should consider starting the moratorium at the end of the month instead of Jan 15 to allow miners to meet their contract obligations and clear bauxite


Yesterday, Malaysian Nature Society (MNS) said the temporary ban was long overdue.

Decision on bauxite mining issue (by Pahang government and the Natural Resources and Environment Ministry)

- Three months suspension of work effective Jan 15.
- Issuance of approved permits (APs) frozen since last week.
- Better coordination among federal and state agencies to ensure directive
- Crackdown on illegal bauxite mining sites.
- Proposal to increase number of personnel at the state Minerals and Geoscience Department for better enforcement.
- Improvement to the regulation and terms and conditions of bauxite
- New terms and conditions to be enforced after the three months' stop-work order.
- Department of Environment established six ad-hoc stations to monitor the water quality at the affected areas (Sungai Riau, Sungai Mabok and Sungai Pinang) due to high concentration of aluminium, mercury and iron.
- Proposal to set up integrated stockpile centre for bauxite to better control the logistic; ensure no more piles of bauxites at Kuantan Port to minimise environmental impact.
